





Every year, more than a million older people are physically, emotionally, financially or sexually abused in the UK. This is a truly damning indictment of how our society views and values older people. Sadly, the abuse of older people is not a new issue, but one that has now reached a critical threshold that can no longer be ignored, nor tolerated.

Every year over a million older people are abused in the UK.

For many years the general public has dug deep to support national charities that deal with the horrifying levels of child abuse, animal cruelty and rising instances of domestic abuse and sexual violence. However, in the background, one unique charity has been supporting the victims of an under-reported and growing crime. The abuse and neglect of older people.

Hourglass is the only UK charity focused on this horrifying yet preventable form of abuse affecting around one million people over the age of 65 each year. But with numbers on the rise, how does a charity like Hourglass ensure more and more people are aware of the neglect, abuse and exploitation of older people?

Hourglass delivers the UK's only helpline dedicated to supporting victims of elder abuse and their families. Callers to **0808 808 8141** get expert advice and support - as well as signposting to other local and national organisations. It's a bespoke service and has recently been bolstered by a new **instant messaging service on [wearehourglass.org](https://www.wearehourglass.org)** and a **confidential SMS service on 07860 052906**.

What remains staggering however is that the abuse of older people is still hidden and unrecognised by most of society. Yet research produced by Hourglass in 2020 revealed that more than a fifth of the UK public have

personally experienced abuse as an older person (65+) or know someone who has been abused.

So why do we have a blind spot when it comes to the abuse of older people? Is it because we simply value the lives of older people less than we do others? It is an indictment of our complacency on this issue that we currently know far more about the abuse and neglect of animals than we do about older people in the UK

Research from Hourglass reveals that more than 1 in 3 people do not believe that 'acts of domestic violence directed towards an older person' count as abuse.


The charity's unique work and analysis illustrates how the abuse of older people is nearing epidemic levels with nearly half of those polled believing that failing to attend to an older person's needs in a timely fashion is not abuse.

What is abuse of an older person?

A single or repeated act or lack of appropriate action, occurring within any relationship where there is an expectation of trust, which causes harm or distress to an older person.

Main types of abuse of an older person




PSYCHOLOGICAL ABUSE

Psychological or emotional abuse involves threats of harm, bullying and harassment and other behaviours or acts of coercive control which deliberately try to scare, humiliate, isolate or ignore an older person.



FINANCIAL OR ECONOMIC ABUSE

Financial or economic abuse is where someone in a position of trust interferes in an older person's ability to acquire, use or maintain their finances.




PHYSICAL ABUSE

Physical abuse is any intentional act or behaviour causing injury, trauma or other physical suffering or bodily harm. This includes instances of fabricated or induced illness or causing an older person to become unwell.



NEGLECT

Neglect occurs when a person deliberately withholds, or fails to provide, suitable and adequate care and support needed by an older person.



SEXUAL ABUSE

Sexual abuse involves any non-consensual sexual act or activity perpetrated against an older person



DOMESTIC ABUSE


Domestic abuse can take many forms, it can be subtle and hard to spot. If you or an older person you know are experiencing this you are not alone, Sadly, this type of abuse can affect anyone, regardless of gender, ethnicity, sexual orientation, disability or gender identity.


































